CONTEST RULES AND INFORMATION

PLEASE REFER TO THE USTA RULEBOOK TO VIEW ALL RULES - USTWIRLING.COM

PAYMENT: For all NY Council events, make check payable to NY Twirling Council. For all other events, payment should be made payable to the organization listed. NYS Championships: payment is by Money Order or Bank Check ONLY.

BOUNCED CHECKS: If a check bounces, you must pay the original balance, plus the bank fee prior to the next entry being accepted. After 2 bounced checks, payment will only be accepted via Cash or Money Order.

REFUNDS: NO REFUNDS WILL BE GIVEN. THIS INCLUDES POSTPONEMENTS DUE TO SEVERE WEATHER.

ORDER OF EVENTS: Doors open 1 -hour prior to start of contest. Contest start times will be at the discretion of the Contest Director. Start times will be communicated a week prior to contest date. You MUST bring your Athlete Record Book in order to be evaluated for Compulsories. *If you do NOT you will NOT be evaluated*. Books can be purchased for \$6 at the contests. Teams will not start prior to 9:45AM, followed by Foundation Events, Strut, Artistic Twirl, Artistic Twirl Pairs, ALL SOLO, Duet, 2 Baton, and 3 Baton. (ORDER OF EVENTS IS SUBJECT TO CHANGE)

CRITIQUE ONLY: Open Solo, 2 baton, and x-strut for critiques only.

<u>RATING LANE:</u> Evaluative event offered for each Championship Events: Solo, Artistic Twirl, 2 Baton, 3 Baton, USTA Strut, Duet, and Artistic Twirl Pairs – Athletes will receive critiques/comments, but do not receive placement or an award.

CONTEST DIRECTOR: Reserves the right to make any changes necessary. No changes may be made once an entry is received. *ONLY* errors made by the contest director will be corrected. Phone entries are discouraged and may be taken at the discretion of the contest director. NO ENTRIES will be accepted the day of the contest. (Exception: Compulsories, which is at the discretion of the contest director. NO REFUNDS WILL BE ISSUED). [SEP]

<u>TEAM DIRECTORS</u>: An entry box for each contest may be brought to the previous contest. Groups performing for COMMENTS ONLY-receive no award. [SEP]

ADMISSION: Adults: \$8, Senior Citizens/Children/Current NYTC Members: \$6, Children Under 5 FREE. Current NYTC Members: You MUST show your current NYTC Membership Card. Admission includes all local contests and each day of the NYS Championships. CONTEST DEADLINES: ALL CONTEST DEADLINES ARE RECEIVED BY THE CONTEST DIRECTOR, INCLUDING NYS CHAMPIONSHIPS. See entry form for info. NY Council Events will not accept phone entries and entries left in boxes must be accompanied by check. Please get your entries in on time. All local contest entries are due 2 weeks prior to the contest date. Please refer to "Calendar of Events" for contest entry deadlines.

SET SYSTEM: The NYTC follows all USTA rules. When it comes to the set system; "Athletes must perform on assigned set number; performing on the wrong set number OR missing assigned set number will result in disqualification."

<u>ENTERING EVENTS</u>: Individuals, Pairs and Teams/Groups may only compete at their level, and ONE level up. Athletes, pairs, teams/groups may not enter more than 2 levels at each contest. (i.e. An athlete may enter Beginner and Intermediate, NOT Beginner and Advanced, and/or NOT Beginner, Intermediate AND Advanced.)

Please remember that ALL wins count, you need to be tracking your wins so that you enter the correct category.

MUSIC SUBMISSION: All music must be submitted digitally to nycouncilmusic@gmail.com by the Tuesday before the contest. Please see Council website for further instructions on submitting digital recordings.

AGE ELIGIBILITY: The date for determining an athlete's age for competition in USTA events is the August 31 of each competition season. Athletes will compete at the age they are on August 31 of each competition season. The competition season runs from September 1 to August 31, therefore for the 2024-2025 season, athletes will compete at the age that they are on August 31, 2025.

This change does NOT apply to the WBTF events of Pre-Trials, Trials, International Cup, and the World Championships. The date for determining an athlete's age for competitions in those WBTF events remains December 31 of each calendar year.
